DEED OF AMENDMENT OF TRUST

THIS DEED OF AMENDMENT OF TRUST is made and executed on this the Twenty Fifth Day of May Two Thousand and Five (25.05.2005) at Bangalore by the Seshadripuram Educational Association, a Society registered under the provisions of the Karnataka Societies Registration Act, 1960, having its office at No. 27, Nagappa Street, Seshadripuram, Bangalore-560 020 represented by its President and Authorised Signatory Sri K M Nanjappa hereinafter referred to as the "Executor" or "Society" (which expression shall wherever the context appears be deemed to mean and include its legal representatives, successors, executors, administrators, assigns, etc.) OF THE ONE PART

WITNESSETH AS FOLLOWS

WHEREAS, the Executor is an Association registered under the provisions of the erstwhile Mysore Societies Regulation Act, 1904, vide Sl.No.S.438 dated 13.04.1944 and the said Society was carrying on the function of running several Educational Institutions from Primary to Graduate Courses and was imparting education in Bangalore.

AND WHEREAS, the Executor in accordance with the desire of the General Body and in accordance with the resolution passed by the General Body on 15.06.1980 duly confirmed vide resolution of the General Body on 20.07.1980, resolved to start a Trust in the name and style of the Seshadripuram Educational Trust.

AND WHEREAS, in accordance with the resolution of the General Body, the Executor started a Trust in the name and style of the Seshadripuram Educational Trust vide Deed of Trust executed on 21.08.1980, by the present and also the then President of the Trust Sri K M Nanjappa, which Deed of Trust is duly registered as Document No. 1967/80-81, Page 70, Volume 2797, with the Head Quarter Sub-Registrar, Bangalore, Gandhinagar, Bangalore.

AND WHEREAS, under the Deed of Trust aforementioned, all the members of the Executor were made the members of the Trust which was formed and the Executor remained as the parent body of the Trust, though the Trust which was formed was to continue with the aims and objectives of the Association, and new members were enrolled as members of the Trust and the Trust carried out all the objectives of the Executor.

AND WHEREAS, at the time of the formation of the Trust by the Executor, the Executor was not dissolved and continued to exist along with the Trust which was formed by the dedication of the properties of the Executor.

AND WHEREAS, the Trustees of the Seshadripuram Educational Trust on the representation to the District Registrar, and on appraisal of the events that had transpired, were intimated by the District Registrar that the Association was not dissolved and that the Trust was part and parcel of the Association.

AND WHEREAS, the Association represented by its then and present President called for the meeting of all the members of the Association and the meeting was held on 29.06.2003, and on which day the elections of the Association was held, after due notice to all the members and various resolutions were passed to the effect that all the

AND WHEREAS, the said resolutions of the members of the Association were placed before the District Registrar together with the Audited Books of Accounts of the Trust, which resolutions were accepted in part and the Accounts of the Trust were treated to be the accounts of the Association and the same was ratified by the District Registrar vide Order dated 16.10.2003.

AND WHEREAS, in accordance with the order of the District Registrar, the Association called for a meeting of the Members of the Association on 30.01.2005, on which date the necessary amendments to be carried out to the Deed of Trust registered as Document No. 1967/80-81, Page 70, Volume 2797, with the Head Quarter Sub-Registrar, Bangalore, Gandhinagar, Bangalore, were passed by the Association.

AND WHEREAS, the amendments to the Deed of Trust which were passed by the Association were placed for approval before the District Registrar in accordance with Section 10 of the Karnataka Societies Registration Act, and the District Registrar in exercise of his powers under Section 10 of the Karnataka Societies Registration Act, 1960, was pleased to ratify the said amendments to the Deed of the Trust and the amendments to the Rules of the Seshadripuram Educational Association vide Order dated 06.05.2005, and in addition directed the present President of the Association Sri K. M. Nanjappa to execute and register the Deed of Amendment of Trust in terms of the Amendment, and hence the present Deed of Amendment of Deed of Trust.

NOW THIS DEED OF AMENDMENT OF TRUST
WITNESSETH AS UNDER

That in pursuance of the above and in continuation of the Order dated 06.05.2005 passed by the District Registrar in exercise of his powers under Section 10 of the Karnataka Societies Registration Act, 1960, the Executor amends the Deed of Trust registered as Document No. 1967/80-81, Page 70, Volume 2797, with the Head Quarter Sub-Registrar, Bangalore, Gandhinagar, Bangalore.

The Deed of Trust as amended after the incorporation of the relevant clauses of the Trust Deed shall read as under :

- At para 2 of Page 2 the words "Rupees Fifty Thousand and Five" and "Rupees Twenty five Thousand and Five" shall be substituted with the words "Rupees Five Lakh and Five" and "Rupees Three Lakh and Five" respectively. The said para 2, shall hereafter read as follows :

"Whereas, the Special General Body Meetings of Seshadripuram Educational Association held on 15.06.1980 and 20.07.1980, in the premises of Seshadripuram Educational Association building, considered that it is expedient to make a formal dedication of all the properties of Seshadripuram Educational Association both immovable and movable to the purpose for which they were constructed and acquired and to make a more definite provision for the upkeep of the Educational Institutions by declaration of public trust in property already used and now in possession of Seshadripuram Educational Association for the promotion of education, literature, fine arts and science, law and B.Ed, courses, etc., constituting all the present members of Managing Committee of the Seshadripuram Educational Association as Trustees and authorised the President of the Managing Committee to execute a Deed of Declaration of Public Trust in this behalf by making therein a special provision that those who contribute Rupees Five Lakh and Five or more and transfer property of like value at the then market rate to the funds of the Trust, be designated as 'Maha Poshakas' and those who contribute Rupees Three Lakh and five or more and transfer property of like value at the then market rate to the funds of the Trust be designated as 'Poshakas' would be entitled to be Trustees for life".

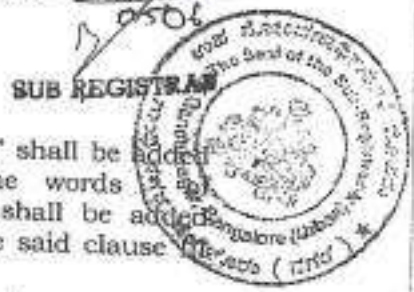

2. At page 4, Clause III, the word "PATRONS" shall be added before the word "ABHIMANIS" and the words "Seshadripuram Educational Association" shall be added after the word "AJEEVA SADASYAS". The said clause shall hereafter read as follows:

" III- That depending upon the nature and volume of work to be transacted in the Trust there shall be a committee of Trustees of not less than 15 in No. including all the present Members of the Managing Committee of Seshadripuram Educational Association and the 'MAHAPOSHAKAS' and 'POSHAKAS' referred to above. Such 'MAHAPOSHAKAS' and 'POSHAKAS' shall be Trustees for life and the Board and Trustees always consisting of majority of elected members as to exceed the Poshakas at-least by two. In case of death of any 'MAHAPOSHAKA' Trustee any of his male descendant in the male line and failing him any other person in his family who in the opinion of the remaining Trustees might be fit to act as such Trustee shall be Trustee in his place. In the case of occurrence of any vacancy amongst the other Trustees by reason of death or resignation or incapacity of any Trustee or for any other cause, the remaining Trustees by a majority of votes appoint a new trustee from among the 'PATRONS', 'ABHIMANIS', 'SAHAYAKAS', 'AJEEVA SADASYAS' of Seshadripuram Education Association and in the case of equality of votes, the President of the Committee of Trustees shall have a casting vote".

3. At page 6, Clause III(a), the words "all categories of" shall be added before the words "Life Members" and the words "of Seshadripuram Educational Association" shall be added after the words "Life Members". The said clause III (a) shall hereafter read as follows:

" III (a) - The Committee of Trustees shall have a right to co-opt persons not exceeding three from among all categories of Life Members of Seshadripuram Educational Association, the term of such co-opted Members shall be co-existent with the next election".

4. At page 6, Clause IV, the words "two" shall be inserted after the words "consisting of" and words "and sixteen" shall be inserted after the word 'MAHAPOSHAKAS' and delete the words : "and also 'ABHIMANIS' who contribute Rupees Fifteen Thousand and five and more, 'SAHAYAKAS' who contribute Rupees Ten Thousand and five, and more and 'AJEEVA SADASYAS' who contribute Rupees Five hundred and one and more. The existing members and patrons of Seshadripuram Educational Association shall automatically become the 'Ajeeva Sadasyas' of the Trust". The said clause IV shall hereafter read as follows:

" IV - The Trustees shall, as soon as possible formulate separate Rules and Regulations for the Management of matters connected with Seshadripuram Educational Trust making special provisions for enrolment of Membership consisting of two 'MAHAPOSHAKAS', and sixteen 'POSHAKAS'.

5. Clause V shall stand Deleted.

6. At Page 7, Clause VI, the words "of Seshadripuram Educational Association" shall be added after the word "General Body" and substitute the sentence: "The period of retirement of Board of Trustees other than Trustees for Life shall be co-terminus with that of the Managing Committee of Seshadripuram Educational Association" with the sentence "The period of retirement of the First Board of (existing members of the Managing Committee) Trustees other than Trustees for life shall be upto the end of October of the year following after three months from the date of declaration of Trust". Clause VI shall be renumbered as Clause V. The said clause V shall hereafter read as follows:

"V - Except the Trustees for life, the remaining Trustees shall retire at the end of every period of 3 years their places being filled in by election by voting by all the Members of the General Body of Seshadripuram Educational Association from among the Patrons, Abhimanis, Sahayakas, Ajeeva Sadasyas at least one being elected from each group if there be a candidate. The period of retirement of the Board of Trustees other than Trustees for life shall be co-terminus with that of the Managing Committee of Seshadripuram Educational Association".

7. Clause VI a), shall be renumbered as Clause VI. The words "1 Asst. Secretary" shall be inserted after the words "1 Joint Secretary". The words "be elected from amongst themselves and Shri K.M.Nanjappa shall be the First President of the Trust and other office bearers continue as such till next election as provided for in VI above" be substituted with the words "hold respective posts in the Seshadripuram Educational Association". The sentence: "But, the post of Joint Secretary (Administration) shall be designated as General Secretary" shall be deleted. The said clause VI shall hereafter read as follows:

"VI - Among the Trustees, there shall be a President, 2 Vice-Presidents, 1 General Secretary, 1 Joint Secretary, 1 Asst. Secretary and 1 Treasurer who shall hold respective posts in the Seshadripuram Educational Association".

8. At page 8, Clause X, the sentence : "The Trustees shall follow in all their business, the new rules, bye-laws, election rules framed separately confirmed and approved by two special General Body Meetings of the Association held on 15.06.1980 and 20.07.1980" shall be deleted. The said clause X shall hereafter read as follows:

"X - That the Trustees shall have power to amend, alter or rescind the rules and to interpret their meaning whenever the rules and byelaws framed do not cover any emergency or is ambiguous provided that such change or interpretation does not conflict with the aims and objects of the Trust. If any difficulty arises in giving effect to the provisions of the "Trust Deed" the majority of the Trustees may, by circulation or otherwise make such provisions not inconsistent with the Trust Deed as appear to be necessary or expedient for removing the difficulty".

9. At page 9, Clause XI, the following sentence shall be inserted: "In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees/Members of Managing Committee/Members of the Governing Body, but the same shall be transferred to another charitable trust, society, association or institution whose objects are similar to those of this Trust and which enjoys recognition under Section 80(G) of the Income Tax Act, 1961. The benefits of the trust shall be open to all irrespective of caste, creed or religion. The funds and income of the Trust shall be solely utilized towards the achievements of the objects and no portion of it shall be utilized for payment to trustees/members by way of profit, interest, dividend, etc.", The said clause XI shall hereafter read as follows:

"XI - That all Deeds and other documents to be executed by or on behalf of the Trust shall be done by the President of the Trust and that the Trust may sue or be sued in the name of the President of the Trust. In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees/Members of the Managing Committee/ Members of the Governing Body, but the same shall be transferred to another Charitable Trust, Society, Association or Institution whose objects are similar to those of this Trust and which enjoys recognition under Section 80(G) of the Income Tax Act, 1961. The benefits of the trust shall be open to all irrespective of caste, creed or religion. The funds and income of the trust shall be solely utilized towards the achievements of the objects and no portion of it shall be utilized for payment to trustees/members by way of profit interest, dividend, etc."
