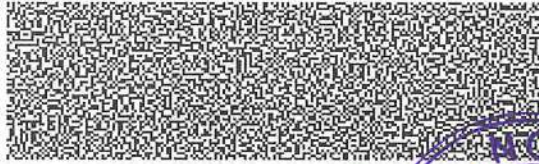
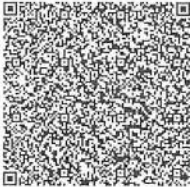

2. That the **SESHADRIPURAM EDUCATIONAL TRUST** is of **Non-Proprietary Character**.


